IMPORTANT - MUST READ Information on the back

You MAY QUALIFY for the Earned Income Tax Credit (EIC) if...

...you lived with 3 or more children in 2013 and your family earned less than \$46,227 (\$51,567*).

...you lived with 2 children and your family earned less than \$43,038 (\$48,378*).

...you lived with 1 child and your family earned less than \$37,870 (\$43,210*).

...you had no children living with you and you earned less than \$14,340 (\$19,680*)

* Married filing jointly

NOTE: This credit is based on Earned Income. You must have worked (have a W-2 or 1099 MISC) in order to qualify. TANF and SSDI earnings do NOT count.

Documents you MUST BRING with you

- **Original SOCIAL SECURITY or ITIN cards** for you, your spouse and all dependents
(some exceptions may be made with pre-approval from the tax coordinator)
- Photo ID for you and your spouse
- 1099-HC Proof of Health Insurance Form or Mass Health/Medicare cards
- W-2, 1098 or 1099-Misc forms
- Proof of all other income
- Proof of childcare you paid (must include provider's ID number)
- Amount you paid for rent
- Child custody agreements and/or divorce decree if divorced and claiming a child

We cannot prepare returns with any of the following:

- Cancellation of debt
- Fr foreign students
- Military income
- International income
- Stocks, dividends or bonds
- Rental real estate
- Business income
- Capital gain or (loss)
- Health savings account deduction
- Pensions and annuities (unless taxable amount has been determined on the income form)

Have your refund electronically deposited into your bank account and receive your refund sooner!
Please bring your checkbook, a cancelled check or a deposit slip. We need the bank's routing number and your account number off of them.
